## Gentari Go x Café Mesra Campaign 2025 – EV Charging Discounts & Café Mesra Rewards By Gentari Green Mobility Sdn Bhd ("Gentari")

The terms and conditions set forth below ("**Terms**") govern participation in the Gentari Go x Café Mesra 2025 Campaign offering EV charging discounts and Café Mesra rewards:

#### 1. Campaign Overview

#### a. Campaign Period:

The Gentari Go x Café Mesra Campaign 2025 runs from **27 August 2025** until **30 September 2025**, inclusive of both dates.

#### b. Eligibility:

The campaign is open exclusively to registered users of the Gentari Go mobile application ("**Users**").

# 2. How to Participate in the Gentari Go Campaign a. Participation Steps:

Users must initiate and successfully complete a single electric vehicle (EV) charging session at any of the participating Gentari EV charging stations listed in below ("Participating Gentari EV Locations") with a minimum spend of RM43.00 (Ringgit Malaysia Forty-Three), exclusive of any discounts, vouchers, or promotional credits, using the Gentari Go mobile application during the Campaign Period (collectively referred to as a "Qualifying Transaction").

### b. Campaign Rewards:

Upon the successful completion of a Qualifying Transaction, Users shall be entitled to receive the following rewards, subject to availability and these Terms:

- i. A 15% discount on the charging fees, automatically applied via promo code **GOMESRA** at the point of charging activation at designated Participating Gentari EV Locations ("Charging Discount"); and
- ii. A unique promotional code entitling Users to ten percent (10%) off the total receipt at selected Café Mesra outlets ("**Beverage Discount**"), delivered via in-app notification on the Gentari Go mobile application or via email within seventy-two (72) hours of the relevant successful Qualifying Transaction. The Beverage

Discount **must be redeemed by 5 October 2025**, after which it shall expire and no longer be available for redemption. The Beverage Discount shall only be applicable at the selected Café Mesra outlets listed below ("**Participating Café Mesra Locations**").

#### c. Reward Application:

#### i. Charging Discount

The 15% discount will be applied instantly to the current charging session upon meeting the eligibility criteria and cannot be deferred, transferred, or applied to any future sessions. If it fails due to technical or operational issues, a unique promo code of equivalent value will be issued via the Gentari Go app for a future charging session at Participating Gentari EV Locations, with usage instructions and validity period provided. The Charging Discount will not be applied if the charging session fails for whatever reason, is unsuccessful, reversed or in an event of a refund. In the event that a charging session is cancelled, unsuccessful, reversed, or otherwise eligible for a refund, only the net amount actually paid by the Users will be refunded. The Charging Discount applied during the session is considered a promotional benefit and will not be refunded or reinstated, regardless of the reason for the refund.

#### ii. Beverage Discount

Each discount code is valid for one (1) transaction, redeemable only at Participating Café Mesra Locations and must be redeemed by 5 October 2025. The discount applies to the total receipt. Discount codes are not valid for third-party delivery or other purchase channels. Users must verify outlet eligibility before redemption.

#### d. Reward Limits and Availability:

- i. Each reward type (Charging Discount and Beverage Discount) is limited to a maximum of FIVE HUNDRED (500) redemptions within the Campaign Period.
- ii. Rewards are issued on a first-come, first-served basis, based on the timestamp of each Qualifying Transaction recorded by the Gentari Go mobile application.

- iii. Once the redemption cap for either reward is reached, no further rewards of that type will be granted.
- iv. Users are entitled to receive multiple Charging Discount and Beverage Discount, provided they complete the Qualifying Transactions each time and meet all applicable criteria.

#### e. Non-Transferability and Non-Exchangeability:

Rewards, discount codes and promo codes are non-transferable, non-exchangeable, and cannot be redeemed for cash or other compensation.

#### f. Non-Stackable:

Discounts under this Campaign cannot be combined with any other ongoing promotions, offers, or subscriptions including Power Pass and Power Pass Lite.
